# Chapter 1: Using IP Office SoftConsole

This manual covers the use of the IP Office SoftConsole application. This Windows application is intended for receptionists and operators. It provides features to support the manual handling and distribution of incoming calls.

 Call history retention period setting – Details of each call in the application's call history are now automatically deleted after a set number of days. The duration is set through the application's preferences. See <u>General console settings</u> on page 78.

# Phone and computer requirements

Ensure you meet the following requirements before using the console.

**Sound and** Sound and media files can be associated with calls. If you use this functionality, you must have a sound card and speakers set up on your computer.

Telephone<br/>supportYou must have an extension to provide the speech path for calls. We<br/>recommend that you use the console with a phone that supports auto-answer.<br/>That applies to most Avaya desk phones.

 Auto-Answer Phones – On these phones, the console is able to make calls which are immediately connected to the phone in order to hear the call progress.

- Non Auto-Answer Phones On these phones, when making a call using the console, the system first calls you and only makes the outgoing call after you answer. This typically applies to:
  - Analog phones and most DECT/non–Avaya SIP phones do not support autoanswer.
  - Avaya telephony applications running on a PC or mobile phone.

The telephone system also supports users who can make and answer calls on multiple telephone devices simultaneously. This is not supported by the console. It will associate itself with one of the user's available telephone devices and only make/answer calls using that device. Where one of those devices is a desk phone on the telephone system, it will use that device.

# Logging In

### About this task

You must log in to use the console. The **Login** window contains details that enable the console to communicate with the telephone system.

#### Procedure

- 1. Click **I** SoftConsole.
- 2. In the Login window, do the following:
  - a. Enter your case sensitive user name or extension number.
  - b. Enter your user password.
  - c. Enter the name or IP address of the telephone system.
    - If you installed the application from a download from web manager or selfadministration, the name should have been automatically added.
  - d. Select the **Use secure communications** check box to enable secure communication between the console and the telephone system.
- To set additional options before you log in, click Expand. See <u>Optional Login Setting</u> on page 9
- 4. To log in, click **OK**.

### **Optional Login Setting**

The following additional settings are displayed on the login menu if you click Expand.

### Profile settings

Whilst using the console, you can rearrange the windows displayed and other settings such as the console language. When you logout, you will be prompted to save any changes as a profile.

In addition, your system administrator can create a set of default templates.

The **Profiles** setting on the login menu allows you to select and reapply the settings of a default or previously saved profile.

#### **Telephony options**

The following describes the check boxes in the **Telephony** section.

Option	Description
Call waiting	When selected, the system provides a call waiting tone when you are on a call and another incoming call arrives. When you end the current call, the new call is immediately presented to you. This option is ignored if you have multiple call appearances on your telephone.
Off-hook station	When selected, this option enables receptions to use the hands-free features on their telephones. The console controls the operation of the telephone. You should only deselect this option if you have an analog telephone where you answer or end calls using the handset.
Show templates	When selected, the default console templates are included in the list of profiles.

- 3. Click 🖽 to save the change as part of your profile.



# The Console's Main Window

In normal view mode, the screen is divided into the possible areas shown in the following image. The profile or template you select when logging in sets whether held calls, BLF, and park slots are shown.

4. Call details panel	Contains a side-by-side display of current call information. The panel on the left contains details of the current or alerting call.
5. Directory panel	The panel on the right contains the directory and individual extension details. The panel on the right can also contain a script file or conferencing details.
6. Queue panel	Displays graphical information on the status of calls held in queues.
7. Held calls panel	Lists call that are on hold.
8. BLF panel	Displays icons that represent numbers you can dial. If the icons represent internal users, the user status is indicated.
9. Park slots panel	Contains up to 16 Park Slot buttons.

### Making unsupervised transfers

An unsupervised transfer is one where you transfer the call without speaking to the transfer destination or wait to see if they answer.

### Procedure

Use one of the following methods for transferring a call:

- Press F2. Select the transfer destination and click **Dial** (Ctrl + D).
- Click Actions > Transfer Call. Select the transfer destination and click Dial (Ctrl + D).
- Drag and drop the call onto the extension within the directory panel.
- Drag and drop the call onto the required BLF.

### Transferring a call without answering it

If you recognize a caller's name or number, you can transfer the call without answering it first. Transferring a call in this way is called an unsupervised transfer. Your configuration can be set to have unanswered calls returned. When a call is returned, **(NoAns)** is shown in the call details panel.

#### Procedure

- 1. Enter the destination extension number in the **Search** field.
- 2. Click on the match required and then click (+(). Alternatively, when down to a single search match, click on (+().

The incoming call is transferred to the destination extension and cleared from the screen.

### Wait for transfer to a busy extension

### About this task

If the extension to which you want to transfer a call is shown as busy by the console, you can queue the call to wait for transfer when the extension becomes free. This avoids the transfer call being sent to voicemail or following the target's forward on busy setting.

This process parks the call on the system using the park ID of the target extension, that is, its extension number plus a single digit between 0 to 9.

#### Procedure

- 1. If you haven't already, answer the incoming call.
- 2. Ask if they would like to wait until the transfer target is no longer busy.
- 3. If they agree, press Ctrl + B. Their call is queued to wait until the transfer extension is free.
- 4. When the transfer extension becomes free, the call returns to the console with a yellow border. The text indicates why the call has returned. In the call details, scroll down to **Reason**:
  - **Timeout** If the call waits longer that the phone system's park timeout (the default is 5 minutes), it recalls to your. Answer the call. If they still want to wait, press Ctrl + B to park the call again.
  - Free The transfer target is now able to take another call. Answer the call to do a normal supervised or unsupervised transfer or you can use Ctrl+R to do an immediate unsupervised transfer without answering the call.

# Parking and unparking calls

#### About this task

You can park a call to handle other tasks. For example, an incoming caller needs to speak to someone urgently but that person is not available. You can park the call in slot 1 and page the person you want to speak to and tell them to pick up the call on slot 1.

Calls remain parked for a specific length of time before returning to the operator. For more information on park time, contact your system administrator.

There are 16 park slots available. When a call is parked in one of the slots, the button label provides information about the call. When a park slot is vacant, the button label shows the park slot number. All operators can see when the call is picked up or ended. Anyone can answer a parked call.

#### Procedure

1. To park a call, while connected to the call, click on a vacant **Park Slot** button to park the call in that slot.

The parked call displays information regarding the call, for example, the source number of the call.

2. To unpark a call, when a call is parked in a park slot, click the relevant **Park Slot** button to unpark the call.

# **Collecting parked calls**

The total number of calls is shown at the end of the bar graph. Each call is shown as a white box if the alarm threshold has not been exceeded. If the number of calls in the queue exceeds the alarm threshold, the calls exceeding the threshold are shown as an amber box.

The longest length of time a call is in the queue is indicated in the text box at the end of the graph. The time is updated whenever a call is queued. When you first log in, you select one of the default console templates. While using the console, you can change various settings and also change the appearance of the screen. You can save

those changes as a personal profile. The current profile or template that you are using is shown in the consolestatus bar.

😵 Note:

To change if the Held calls and BLF panels are hidden or shown, you must be logged in to the console as an Administrator.

#### Loading and saving a profile

#### About this task

You can load a new profile when logging in. You can save changes to your profile manually, or you can configure console to automatically save every change.

- To load a profile, do the following when logging in:
  - 1. Click **Expand**.
  - 2. Select the required profile.
- To manually save your current profile changes, select **File > Save Profile**.
- To manually save your changes as a new profile, do the following:
  - 1. Select File > Save Profile As.
  - 2. Enter a new file name.
  - 3. Click **OK** to save your change.

The status bar displays the new profile name.

To configure the console to automatically save changes, go to 
 Preferences > SoftConsole.

#### **Editing a profile**

In **View**, you can hide or show the Busy Lamp Fields (BLF), Held calls, and Park slots panels. You can also access the normal view options.

## **Cannot use the Force Extension Status or Group Service Status features**

#### Cause

There is an interval of several seconds after the console has been started that the operator cannot use these features. During this interval, the Directory Entry Properties and Group Service Status forms will display a **Close**button, rather than the **OK** and **Cancel** buttons.

#### Solution

Close the form, wait several seconds and then reopen the form to try again. **Related links**

## Unanswered calls are not returned to the operator

#### Cause

For calls to be returned to the operator when they are not answered, a Transfer return time must be set in the User Telephony tab in the telephone system's configuration.
