## INFORMATION ABOUT THE SERVICE

### SERVICE DESCRIPTION

Cloud PBX provides your business with a fully functional office phone system, hosted in the Cloud and delivered via a broadband internet connection.

### MINIMUM ACCESS REQUIREMENTS

To access the service, you will need an internet connection with a minimum of 100/100Kbps of available bandwidth per simultaneous call, with no packet loss, and a ping of less than 150 ms. You will also need an IP enabled handset or soft- phone client and may need extra hardware depending on your requirements e.g. router and switches.

<b>Minimum Term</b>	60 Months
<b>Exclusions</b>	All standard calls not listed below as Included, plus calls to international destinations and premium service numbers are billed on top of the minimum monthly charge.
<b>Minimum Channels</b>	This plan requires a minimum of 25 users.
<b>Bundle Requirements</b>	This plan does not require bundling with another service.
<b>Plan Limitations</b>	All licences must be on the same plan. Mix and match between plans is not available.
